

MINUTES OF COUNCIL MEETING

June 4, 2018

A regular council meeting was duly called to order at 5:00 p.m. by Mayor Dorothy Behne on Monday, June 4, 2018 with members Dorothy Behne, Matt Larson, Kurt Olson, Brad Ringnell and Jeff Ross present. Also present City Admin/Police Chief Brad Hughes and Deputy Clerk Kym Christiansen.

In open public comment, Earl Cordes on behalf of the Sherburn Lion's Club presented the idea of naming the new shelter house after Gerald (Jerry) Jenkinson who was a fifty year members of the Lion's Club and a former Mayor of Sherburn.

Motion by Ringnell to approve the agenda as updated, second by Larson, carried.

Motion by Ringnell to approve the minutes as written and sent to each council member for study, second by Olson, carried.

Consent agenda including payment of bills was declared approved.

Doug Standerwick with Bargaen Incorporation presented information regarding the application of replay as opposed to chip-sealing the streets. Standerwick explained that replay will be fill in the voids in the pavement on the streets and will not allow water to absorb in the streets. He also highlighted the benefits that the City of Hutchinson, MN has seen in their roads by using replay. Replay can only be used on new streets. Bargaen Incorporation is trying to push preventive work on roads instead of maintenance work.

Motion by Olson to approve a pull tab request of \$500 for the Sherburn/Welcome Police Department for the annual bike rodeo, second by Ross, carried.

City Admin/Police Chief Hughes presented quotes that were received the seal-coating as well as the replay costs from Bargaen. Discussion was held on the benefits of doing seal coating versus replay. Motion by Ross to authorize the application of replay as quoted from Bargaen and to have Lynn St seal coated, second by Ringnell, carried.

Motion by Ringnell to approve the naming of the new shelter house at the City Park in memory of Gerald (Jerry) Jenkinson, second by Olson, carried.

Administrator Report

- Steve Larson asked about the possibility of having a chiropractic office in his residence and that is allowed in the City Code.
- Update on the Water Treatment Project was given and remaining work will started either the week of June 4 or June 11 with a completion date of early July, which is when the open house will be schedule for.

In other business, Councilor Ringnell asked if weeds at the fire hall could sprayed as soon as possible. Councilor Ross asked when the new part of the street light will be installed. Councilor Larson stated that there several properties that need to be mowed and trimmed especially around objects. Mayor Behne asked if the sign for the South Park has been ordered.

Motion to adjourn by Ringnell, second by Olson, carried. Meeting declared adjourned at 6:27 p.m.
