

## MINUTES OF COUNCIL MEETING

April 1, 2019

A regular council meeting was duly called to order at 5:00 p.m. by Mayor Jeff Ross on Monday, April 1, 2019 with members Carlee Hunter, Matt Larson, Kurt Olson, Brad Ringnell and Jeff Ross present. Also present City Admin/Police Chief Brad Hughes and Deputy Clerk Kym Christiansen.

Motion by Ringnell to approve the agenda, second by Olson, carried.

Motion by Ringnell to approve the minutes as written and sent to each council member for study, second by Larson, carried.

Consent agenda including payment of bills was declared approved.

Helen Murphy and several residents of Swanson Drive were present to voice their concerns with the truck wash being built on the west side of County Road 13. The concerns that were raised are future problems with the City sewer and water system, smell, noise from the truck, animals, and storm water runoff. They are asking the city to listen to the concerns.

Recognized the retirement of Don Dorschner from the Sherburn Fire Department after 26 years of dedicated service to the Sherburn Fire Department.

Recognized Deputy Clerk Christiansen on receiving her Certified Municipal Clerk certification in March as well as Public Works Employee Paul Schoen on achieving his class D Water License. Schoen will be working towards his class C which will allow him to be the operator for the water plant then the City would be able to discontinue the contract operator by half each month.

A petition was presented to the Council asking to have clean-up day done at the curb this year instead of at a central location. The date of citywide clean-up is May 11. Estimated costs for curb side pick-up would be around \$5480 plus State and County solid waste tax while a centralized location has a cost of \$2731.86 plus State and County solid waste tax. No action was taken.

Motion by Ringnell to increase the pay per license for Public Work to \$1.50 per hour, second by Hunter, carried.

### Administrator Report

- Liquor Store cooler is installed along with the new ceiling and flooring is being installed.
- Updated schedule for Temperance Lake Ridge expansion was presented for review
- Judge's ruling on 105 N Main was presented for review.

In other business, Councilor Hunter asked if a barricade could be placed by the Zender property due to unsafe conditions, if the dumpster behind the Liquor Store and Community Hall could be emptied, payment status of the outstanding Revolving Loan Fund and if the 10:00 p.m. whistle can't be sounded. Councilor Larson asked for an update on the basket system at Kum and Go. Mayor Ross stated the street lights would be going up next week and is going to talk with the Lion's Club about helping with Clean-up day.

Motion to adjourn by Ringnell, second by Olson, carried. Meeting declared adjourned at 6:13 p.m.
